(the "Offeror") exercising its right under Section 215(1) of the Companies Act 1967 of Singapore ("Companies Act") on 13 September 2022 to compulsorily acquire all the Shares from shareholders of the Issuer who have not accepted the Offer (defined below) as at the close of the Offer ("Dissenting Shareholders").

As ELY owns more than 20% of the shares in the capital of the Offeror, ELY is deemed to be interested in the Shares.

On 17 May 2022, Oversea-Chinese Banking Corporation Limited ("OCBC"), for and on behalf of the Offeror, announced a voluntary conditional cash offer ("Offer") to acquire all the Shares, other than any Shares held in treasury and those Shares held, directly or indirectly, by the Offeror as at the date of the Offer.

On 1 August 2022, OCBC, for and on behalf of the Offeror, announced, inter alia, that (a) the Offer closed at 5.30 p.m. (Singapore time) on 1 August 2022, and (b) the Offeror is entitled to, and will in due course, exercise its right of compulsory acquisition under Section 215(1) of the Companies Act to compulsorily acquire all the Shares from Dissenting Shareholders at a price equal to the final offer price of S\$0.40 ("Compulsory Acquisition").

The documents in respect of the Compulsory Acquisition were despatched to Dissenting Shareholders on 12 August 2022. On 13 September 2022, OCBC, for and on behalf of the Offeror, announced the Offeror's exercise of its right to undertake the Compulsory Acquisition.

Immediately before the Compulsory Acquisition of the 50,314,384 Shares held by the Dissenting Shareholders, the total number of (a) Shares owned, controlled or agreed to be acquired by the Offeror and its concert parties and (b) valid acceptances of the Offer, amount to an aggregate of 602,346,716 Shares, representing approximately 92.29% of the total number of Shares.

Following the Compulsory Acquisition, the Offeror shall be the sole shareholder of the Issuer.
