On 31 May 2022, Sanjuro United Pte. Ltd. ("Offerror") despatched its Offer Document in relation to its voluntary conditional general offer ("Offer") for all the issued and paid-up ordinary shares ("Shares") in the capital of Hwa Hong Corporation Limited ("the Company") other than any Shares held in treasury and those Shares held, directly or indirectly, by the Offeror as at the date of the Offer (collectively the "Offer Shares" and each, an "Offer Share").

The Offer was declared unconditional in all respects on 27 July 2022 ("Offer Unconditional Date"), and the settlement of the consideration due in respect of the Shares tendered in acceptance of the Offer on or before the Offer Unconditional Date and the transfer of such Shares to the Offeror are expected to take place within 7 business days of the Offer Unconditional Date ("Settlement") in accordance with the terms and conditions of the Offer.

Mr Ong Mui Eng and his spouse tendered their Shares in acceptance of the Offer before the Offer Unconditional Date. Accordingly, immediately following the Settlement, Mr Ong Mui Eng will cease to have any interest in the Shares.

Percentage figures in this disclosure are calculated based on the Company's issued share capital of 652,661,100 Shares (excluding 842,900 treasury shares held by the Company).
