APPENDIX 1

Appendix 1 to Notification to SGX

Circumstance(s) giving rise to the interest

1. Pursuant to an Order of Court dated 10 January 2005 and 2 Orders of Court dated 2 February 2005, the High Court of Singapore sanctioned the capital reduction applications of the following companies ("*Capital Reduction Exercises*"):
 - (a) Ong Holdings (Private) Limited ("*Ong Holdings*");
 - (b) Bee Tong Trading Company Private Limited, being a wholly-owned subsidiary of Ong Holdings; and
 - (c) International Foundation Engineering Pte Ltd, being a wholly-owned subsidiary of Ong Holdings.

(collectively, "*the Companies*")

Copies of the Orders of Court are annexed hereto as Appendix 2.

2. The Capital Reduction Exercises are effected by the cancellation of 37.91% of the issued and paid-up or credited as fully paid-up shares in the capital of each of the Companies which are held by some of the shareholders of the Companies ("*Outgoing Shareholders*").
3. In return for the aforesaid cancellation, each company would then distribute to the Outgoing Shareholders 37.91% of the issued and paid-up share capital of the company *in specie* of 37.91% of:
 - (i) the equity interest in other companies held by the Companies; and
 - (ii) the other assets of the Companies, subject to the Outgoing Shareholders contributing 37.91% of all liabilities of the Companies as of a certain date ("*Capital Distribution Exercises*").
4. Pursuant to the Capital Distribution Exercises, as one of the Outgoing Shareholders, I received 46,993,953 shares in Hwa Hong Corporation Limited ("*Hwa Hong*") which resulted in the change in the percentage level of my interest in Hwa Hong as set out in the Notice of Substantial Shareholder's Interests.

Amount of consideration (excluding brokerage and stamp duties) per share paid or received

5. The consideration for the 46,993,953 shares is:
 - (a) the cancellation of the portion of 37.91% of the issued and paid-up or credited as fully paid-up shares in the capital of the Companies proportionate to the number of shares I held in the Companies; and
 - (b) the contribution to 37.91% of all liabilities of the Companies proportionate to the number of shares I held in the Companies.

6. The number of shares I held in each of the Companies is as follows:

- (a) 2,676 out of a total of 15,000 shares in Ong Holdings;
- (b) 356,800 out of a total of 2,000,000 shares in Bec Tong Trading Company Private Limited; and
- (c) 2,676,000 out of a total of 15,000,000 shares in International Foundation Engineering Pte Ltd;
